COVID-19 Response

Despite all the challenges of 2020, including the reassignment of many staff from the END HIV MN team to coronavirus response efforts, it has been a big year for END HIV MN.

The pandemic has required the HIV Supports Section at the Minnesota Department of Human Services (DHS) and the STD/HIV/TB Section Minnesota Department of Health (MDH) to make many changes to business as usual, including:

- Making critical changes to the Program HH/AIDS Drug Assistance Program to ensure that eligible clients continued to receive needed HIV medications.
- Providing funding so that clients could receive additional food vouchers and personal protective equipment for themselves and their family members.
- Providing guidance and flexibility to partner organizations to adapt service delivery.
- Working with the AIDSLine to maintain an [HIV/AIDS Community Services Directory during COVID-19](http://www.JustUsHealth.org/COVID-19servicedirectory) for a centralized place to find up to date information.



Shout Out: Thank you to all staff at partner organizations who have creatively adapted to continue to provide services and meet client needs during this time, especially front-line providers. Virtual HIV & COVID-19 Community Meeting



DHS, MDH, the Hennepin County Public Health Ryan White Program and the Midwest AIDS Training and Education Center – MN/IA branch collaborated to host the April 2020 Virtual HIV & COVID-19 Community Meeting.

Attended and viewed by over 200 people, the webinar covered information for people living with HIV and service providers.

DHS and the Hennepin County Public Health Ryan White Program received over \$575,000 in COVID CARES Act Ryan White funding to help Minnesota prepare, prevent, and respond to COVID-19 among people living with HIV.

By partnering with Medical Case Managers, DHS and Hennepin County were able to get 645 people living with HIV to make their voices heard and influence how the money was spent in Minnesota.

Photo Shoot

A cross-sector partnership dedicated to ending HIV stigma in Minnesota met over the course of a year to plan an HIV awareness project. In February 2020, this planning resulted in a photo shoot where 19 models who are living with HIV or taking PrEP for HIV prevention took pictures to be used in future awareness campaigns and educational materials. The models were compensated for their time and stories and received professional make-up and headshots during the shoot.

Statewide Inventory of Efforts

Goal 5 of END HIV MN calls for achieving a more coordinated statewide response to HIV. To reach that goal, MDH and DHS have compiled a statewide inventory of all ongoing efforts being made to address HIV in Minnesota. Finished in fall 2020, the inventory will help MDH and DHS:

- Identify gaps in services.
- Identify opportunities for collaboration and new partnerships.

Shout Out: We were incredibly impressed to learn more about the work being done by over 100 organizations statewide that are included in the inventory. We look forward to strengthening existing partnerships and forging new ones as we work together to end HIV in Minnesota.

Partner Engagement Survey

Ending HIV in Minnesota is bigger than any one individual or organization. Success will depend on all of us to get involved, coordinate, and collaborate. DHS, MDH, and the Hennepin County Public Health Ryan White Program worked together to create a Partner Engagement Survey. The survey asked staff at partner organizations how we can more effectively engage them, more effectively engage community members, and how to improve partnerships.

The survey was open in June and July of 2020 and the [Partner Engagement Survey Summary \(PDF\)](#) was published online at [END HIV MN Reports in](#) September of 2020. We are incredibly grateful for the advice and suggestions on how to improve from those who took the survey.

MDH and DHS staff are working on the following projects using the results from the engagement survey and other community input:

- Creating a statewide HIV community engagement plan.
- Assessing and improving communications to make sure people are receiving the right information at the right time.
- Improving our partnerships between the organizations MDH and DHS collaborate with and fund.

Shout Out: Thank you to all of our partners who took the time to complete the survey and help us improve. Your honest feedback, expertise, and innovative ideas are exactly what we need to see an end to HIV in Minnesota.





Key Informant Interviews

END HIV MN calls for DHS and MDH to increase the organizational capacity of small, new, or yet-to-be-formalized culturally specific, community-based organizations to successfully secure and implement state and federal HIV funding.

To work towards that goal, DHS and MDH partnered to do Key Informant Interviews with sub-recipient (or grantee) partner agencies that receive, have received, or could receive HIV related funding from MDH and/or DHS to provide HIV prevention or core medical and support services.

A total of 23 organizations participated in 16 individual and group interviews during the summer of 2020. Their feedback was

compiled and in September of 2020 the [Summary of Interviews with Grantees and Potential Grantees \(PDF\)](#) was posted online at [END HIV MN Reports](#).

MDH and DHS are currently assessing the feedback to determine what can be implemented without policy change and what suggestions require agency, state, or federal policy change. We look forward to implementing these suggestions as we are able to the next time we issue an HIV-related Request for Proposals (RFP).

Shout Out: We appreciate our partners – old and new—who took the time to give us honest and transformative feedback on how we can improve the grantmaking process. Your insight and expertise are incredibly valuable. We welcome both your partnership and accountability as we reimagine our grantmaking to be more equitable.

Collaborations

In 2020, the END HIV MN team was also busy supporting other work to end HIV in Minnesota, such as:

Provider Town Halls Series

MDH, DHS, and the Midwest AIDS Training and Education Center partnered to create a Virtual HIV Town Hall Series for health care providers. The first Town Hall focused on the story of the background of encampments from those on the front lines and details about the current HIV outbreak in this context.

END HIV MN calls for increased provider education and training that focuses on evidence-based strategies to prevent and treat HIV, as well as more training to help health care providers increase their cultural responsiveness.

HIV Outbreak Response

Minnesota is currently experiencing an HIV outbreak among people who inject drugs, many of whom are unhoused. END HIV MN staff have supporting outbreak response work by providing planning assistance for and participating on multiple work groups. This work has included collaborative efforts with state, county, and community partners. For example, a working group has been meeting to identify barriers in accessing shelter and housing options and identify creative solutions to overcome those barriers

Shout Out: Thank you to the HIV Outbreak Public Engagement Group (HOPE) and to all of the organizations partnering to respond to the HIV outbreak, including: Hennepin County Public Health Ryan White Program, Hennepin County Healthcare for the Homeless, Hennepin County Public Health – Red Door Clinic, the City of Minneapolis, Native American Community Clinic, Hennepin Healthcare – Positive Care Center, Southside Harm Reduction Services, the Midwest AIDS Training and Education Center – MN/IA branch, JustUs Health, Minnesota AIDSLine, Ramsey County Public Health – Clinic 555, the Aliveness Project, Indigenous Peoples Task Force, and many others.

2020 Comprehensive Needs Assessment

Done every 5 years, the Comprehensive Needs Assessment is a partnership between DHS, the Hennepin County Public Health Ryan White Program, and the Minnesota Council for HIV/AIDS Care and Prevention. The Needs Assessment team did a great job of pivoting to a new virtual environment, while collecting over 800 surveys from people living with HIV who represent all of the different communities that are impacted by HIV across Minnesota.

END HIV MN calls for increasing the meaningful inclusion of voices from the communities most affected by HIV in decision making about HIV programs and funding. One of the critical ways that people living with HIV shape HIV service delivery is through the Comprehensive Needs Assessment.

Shout Out: Kudos to the Needs Assessment Team for adapting to virtual survey delivery and still getting a record-breaking number of surveys completed. We also thank every person living with HIV who took the time to complete the Needs Assessment and make their voices heard.
