#### Amanda Beaudoin, DVM, PhD

Doctor Beaudoin is Director of One Health Antibiotic Stewardship at Minnesota Department of Health. Amanda works with stakeholders of the state's One Health Antibiotic Stewardship Collaborative to advance antibiotic resistance and stewardship activities in human, animal and environmental health, and agriculture. She holds a Doctor of Veterinary Medicine degree from Cornell University, a PhD in veterinary epidemiology from the University of Minnesota, and board certification by the American College of Veterinary Preventive Medicine. Amanda has worked in equine and small animal clinical practice and conducted research on influenza in swine, poultry, and human populations. Amanda has worked for the Centers for Disease Control and Prevention, where she most recently worked in the area of antimicrobial resistance, providing infection prevention and control support to healthcare facilities and assisting foreign governments with antibiotic resistance surveillance.

## Jean Rainbow, MPH, RN

Jean Rainbow works for the Minnesota Department of Health in the Healthcare-Associated Infection and Antimicrobial Resistance Unit and serves as the state HAI coordinator. She is a registered nurse and has an MPH in Epidemiology from the University of Minnesota. ## Jeffrey S. Gerber, MD, PhD
